

广东外语外贸大学南国商学院—澳大利亚昆士兰大学 2+2 双学士项目介绍

一、昆士兰大学简介

昆士兰大学（The University of Queensland）建于 1910 年，位于澳大利亚昆士兰州首府、东部海滨城市布里斯班，是一所综合类研究型公立大学，学术水平在澳大利亚高校排名第三，是澳大利亚“八校联盟”（Group Of Eight）成员，2022 年 QS 世界大学排名第 47 位、2022 年 U. S. News 世界大学排名第 36 位、2022 年泰晤士高等教育世界大学排名第 54 位；杰出校友有 2 位诺贝尔奖得主、117 位罗德学者，伦敦国王学院校长埃德·伯恩、加州大学旧金山分校校长山姆·霍古德，澳大利亚总督昆廷·布赖斯、前澳大利亚总理陆克文，全球第二大化学公司陶氏化学董事会主席兼 CEO 安德鲁·N·利弗里斯等。

昆士兰大学的商业、经济与法律学院（Faculty of Business, Economics & Law）已获 AACSB 和 EQUIS 双重认证，在 2022 年泰晤士高等教育世界大学学科排名中，商科经管类专业位列全澳第 1、全球第 39。



二、对接专业

广东外语外贸大学南国商学院的会计学、国际金融、工商管理 3 个本科专业，可分别对接昆士兰大学商业、经济与法律学院的经济学、商学、工商管理学士学位专业。

三、学习模式

按照 2+2 模式，会计学、国际金融、工商管理 3 个专业的本科生，先在广东外语外贸大学南国商学院学习两个学年，完成规定的课程和学分，平均成绩至少 75 分（百分制，其中微积分 60 分以上），并取得雅思成绩（总分至少 6.5，且各单项不低于 6.0），或者托福成绩（总分至少 87 分，且各单项至少达到写作 21 分、口语 19 分、听力 19 分、

阅读 19 分), 然后在昆士兰大学对接学习两个学年, 主要修读该校商业、经济与法律学院的经济学、商学或工商管理学士学位课程。在学习期限内同时达到两校毕业与学位授予条件的学生, 将分别获得广东外语外贸大学南国商学院和昆士兰大学的学士学位。

【注】具体录取专业由昆士兰大学根据申请人国内修读课程的匹配结果决定。
